
In Canadian federal politics, everyone can participate in the process. One doesn't have to be a lawyer to be a serious political participant. Many of those are persons like me,

Seniors

Seniors have spent a lifetime working hard for Canada. It is time the Canadian Government started working hard for seniors. Seniors who work are still required to pay Employment Insurance premiums, even though they are ineligible to receive benefits.

With the baby boomers soon retiring, Canada's demographic face is changing, presenting many challenges. Senior's issues are complex, involving coordinating ministries from Parks and Heritage to Health.

Conservatives have a detailed plan to address seniors issues, with specific policies such as:

- Appointing a Minister Responsible for Seniors, to ensure that the unique needs of seniors are being addressed
- Ensuring the sustainability of the Canada Pension Plan
- Providing a caregiver tax credit to children and family members who provide care to seniors
- Ending mandatory retirement
- Ensuring that seniors do not pay EI premiums when they are unable to collect EI

Housing and Poverty

Over a decade has passed, and over \$2 billion has been spent on shelter housing, but still homelessness and poverty in Canada have increased. Approximately 15,000 people still live in emergency shelters. One must question the efficiency of a system that has spent so much, yet delivered so very little to help Canadians obtain decent, affordable housing.

During this period, middleclass Canadians have seen their incomes rise only 3%, while federal spending has

increased over 50%. An increase in adult poverty also causes an increase in child poverty.

Conservatives have a multifaceted plan to address homeless and poverty issues, such as:

- Investigating where the \$2 billion for shelter housing went
- Tax initiatives and support programs to encourage home ownership and accessible and affordable rental accommodation
- Partnering with local and provincial governments, business, and community groups in dealing with affordable housing issues
- Incentives to encourage private sector low-income housing development



Education

Education has suffered under 13 years of Liberal government. Research and development investments are low, with the United States spending nearly twice as much on R&D. Meanwhile, unsurprisingly, post-secondary tuition costs have increased in almost every province.

Education is important not just for its obvious intrinsic value, but also to support a dynamic economy and flexible workforce. Flexibility is a necessity in today's global marketplace and is imperative, if Canadians are to keep their relatively high standard of living. Education is vital to our economy.

Conservatives have a plan to make post-secondary education more accessible while respecting provincial jurisdiction, by:

- Making scholarships and bursaries tax free
- Creating an independent Canada Education Transfer to the provinces, specifically geared towards education and increasing according to inflation and demographic growth
- Creating greater flexibility in student loans by providing preferred interest rates and income-contingent loans
- Eliminating parental income and assets in the student loan application process

Families and Child Care

Canadian families are hurting these days. More parents are having to work longer hours just to support a growing tax burden and shrinking incomes, due to Liberal fiscal ineptitude. Families under this government have less income, less health care, more taxes, and still no choices on child care.

Parents and families need a break these days, but just as importantly, they need choice. A one-size fits all approach to child care limits the choices of families, but that's exactly what the Liberals are proposing to do. The Liberal child care plan would do little to help the diverse range of families in today's society, such as rural areas and single-income households.

Conservatives believe that parents and families are in the best position to determine what's good for their own families. We believe that support should go to all parents and families raising children, especially lower and middle income parents, including a child tax credit to help working families and also tax credit measures for parents who choose to stay at home with their children.
